

# TERMS & CONDITIONS



## WOWSA-ASCA OPEN WATER SWIMMING COACHES CERTIFICATION COURSE

## 1. Registration and Payment

- 1.1. To secure their spot in the course, all participants must complete the online registration form and submit payment in full or allow for instalments payment as we offer.
- 1.2. Registration fees are non-refundable except under the conditions stated in Section 6 (Cancellation and Refund Policy).
- 1.3. Payment methods accepted include credit card, bank transfer, instalment payments, and other options listed during registration.

## 2. Course Content and Delivery

- 2.1. The course content, including schedules, instructors, and venues, is subject to change at the organizers' discretion.
- 2.2. Course materials, either digital or printed, will be provided to participants. They are intended for personal use only and should not be distributed without permission.
- 2.3. The course will be in English, and participants must understand proficiently.

## 3. Attendance and Participation

  - Certificate of Participation: Certificate of Participation: This award is given to the total course participants.
  - WOWSA-ASCA Open Water Swimming Coaching Certificate: Awarded to participants who successfully passed all the online examinations and completed the in-person learning course.
  - 4.2. Certification is contingent upon meeting all course requirements, including attendance, participation, and passing any assessments or examinations.
  - 4.3. Certification may be revoked if it is found that the participant did not adhere to the course rules or engaged in unethical behaviour.
